

## J-1 STUDENT VISA INFORMATION

#### STUDYING IN THE USA

In order to study legally in the United States, you will need a student visa. To obtain a student visa you will need to be issued a DS-2019. Drew University is authorized to issue the form DS-2019 to enable international students to apply for J-1 student visas. In order to secure an DS-2019 from Drew University, you must be admitted to the University and you must be able to provide documentation verifying your ability to pay for your education and support yourself while in the U.S.

#### WHAT IS A FORM DS-2019 AND DO I NEED ONE?

A Form DS-2019 tells the U.S. government that you are eligible for J-1 student status. It certifies that:

- 1. You are or expect to be a "bona fide" student.
- 2. You meet our admissions requirements
- 3. You will pursue a full course of study.
- 4. You proved you have enough money to study and live in the U.S. without working illegally or suffering from poverty.

#### DOES EVERYONE NEED AN DS-2019

If you are maintaining another nonimmigrant status in the U.S., you do not have to have a DS-2019 and may attend school full- or part-time. Dependent children in E,H,I,J,L,M,N,O,P,R, or S status need to change status after their 21<sup>st</sup> birthday or if they marry.

## TIP #1

It is highly recommended that at least part of your financial support comes from your home country. This is important for getting your student visa!

#### WHAT ARE THE RULES FOR GETTING AN DS-2019?

- 1. You must be a "bona fide" student, accepted to a full-time program of study.
- 2. You must provide us with evidence that you can support the costs of living and studying in the U.S. for the duration of your program of study.
  - Do not expect to work in the U.S. to help meet your costs. On-campus employment is limited and competitive; off-campus employment is strictly controlled by the U.S. Citizenship and Immigration Services.
  - Carefully review the estimated cost of attendance on Drew's website. This is the amount that you must prove you can support for your program of study.
  - These requirements are not negotiable. They represent a modest average budget that does not include luxuries. We strongly recommend that you budget at least 10% more if possible. We also suggest that students and their families look closely at the cost of living and studying in the U.S. and make careful plans to be sure their needs will be met.
  - Expect annual increases in tuition and living costs of approximately 10%.

#### SOURCES OF FINANCIAL SUPPORT

Financial support can come from any combination of the following sources in the U.S. or abroad:

- 1. Personal funds that come from our own resources- not those of your relatives. Unless you have enough cash to support yourself for our entire program of study or can prove other sources of personal income, you will need a sponsor with an income sufficient to support you.
- **2. Funds from this school** such as scholarship. Drew offers scholarships to international students based on academic performance. These scholarships are limited and will only partially cover your tuition.
- 3. Funds from "Sponsors" (parents, relatives, friends, governments, and organizations). If you have a sponsor they must complete the Affidavit of Support and provide financial documents as support. A separate Affidavit o support must be completed by each sponsor.

## DOCUMENTARY EVIDENCE REQUIRED

Complete the application for DS-2019 and submit with financial evidence by mail, fax, or e-mail attachment. We recommend that you submit these documents at the time of application in order to issue your DS-2019 more promptly.

#### All documents must be:

- 1. In English.
- 2. Less than two months old.
- **3.** Photocopies or faxes, not originals. You will need the originals for the American Embassy when you apply for your visa.

## **TIP** #2

A sponsor should promise only as much money as he or she is able to give you. Some sponsors believe that the more money they promise to give, the easier it will be to get your DS-2019

The most common reason for rejection of financial documents is that we do not believe the sponsor can afford to give as much as promised. A sponsor should promise only what he or she intends to give and only as much as can be afforded.

#### **TIP #3**

If there is no proof of income submitted, bank statements must prove that there are sufficient funds to cover the program of study.

## SPONSORS OF CASH SUPPORT:

#### 1. Affidavit of Annual Cash Support

This form should be completed by each sponsor. All questions must be answered.

#### 2. Proof of Income

## Individual Sponsor (any of the following):

- Salary statement on letterhead stationary with most recent pay stubs, or
- If self-employed, salary estimate from private accountant or bank, or
- Income tax returns or receipts with most recent pay stub, or
- Pay stubs for at least six months, or
- Documentation of investments

#### **Company Sponsor**

Original letter on company letterhead stating annual support from the company

#### 3. Bank statement in the Name of the Sponsor

A monthly statement of balances and deposits indicating the type of currency. If another person's name appears on your bank statement, that person must complete a separate affidavit or submit a statement permitting those funds to be considered as financial support for the student

A monthly statement of balances and deposits indicating the type of currency.

## **Copy of Your Award Letter**

Upon admission, Drew will provide you with a letter stating exactly what you will be receiving and for how long. Only students who are academically qualified for a merit scholarship will receive an award letter.

## AFFIDAVIT OF SUPPORT AND PROOF OF FINANCES

## WHAT DOES AFFIDAVIT MEAN?

By completing this affidavit, you are swearing to the U.S. government that you will provide this student with a specific amount of money from your own financial resources to study at Drew University and live in the U.S. You are also proving that you can afford the support you are promising with the documents you have attached.

Before signing it, you must understand that you are making a financial commitment to the student that should not be broken. Sponsors who fail to provide the promised support force students to drop out of school and cause pain and suffering. Do not expect that the student will be able to help support the costs through employment. Employment is strictly controlled by U.S. Citizenship and Immigration Services and very limited.

#### HOW TO COMPLETE THIS FORM

- Each sponsor should complete a copy of this form.
- Fill this form out completely in English. Promise only the amount of money you are able to give.
- Attach evidence (as outlined) proving your ability to provide cash support for every year of the student's study.

## ACCEPTABLE EVIDENCE OF ABILITY TO PAY

#### **DOCUMENTS MUST BE:**

- In English
- Less than two months old
- Photocopies, scans, or faxes (not originals)

#### **PROOF OF INCOME** (Any of the following)

- Salary statement on letterhead stationary with most recent pay stub, or
- If self-employed, salary estimate from private accountant or bank, or
- Income tax returns or receipts with most recent pay stub, or
- Pay stubs for at least six months, or
- Documentation of investments
