



INDIVIDUAL SPONSOR SUPPORT FORM FOR INTERNATIONAL STUDENTS

International students must show proof of finances for at least the first year that they are studying at Drew University in order to get an I-20 form for F-1 status or an DS2019 for J-1 status. This form is necessary to show the connection between the student and his/her sponsor.

To The Student:

This form is for an individual (not an organization) who will be sponsoring you. If your sponsor is an individual, this support form must be accompanied either by an original official bank statement (copies and internet produced bank statements will not be accepted, and the bank statement becomes the property of Drew's immigration files and will not be returned), or by a letter from the Sponsor's bank on bank letterhead stating the bank's name, address (including the country) and phone number (including foreign area code); the sponsor's name; a sentence that indicates how much money the sponsor has in the account in local currency and U.S. dollars; and what exchange rate was used. The bank documents must be on official bank letterhead/paper (plain paper computer print-outs and internet print outs will not be accepted) and should include the address and phone number of the bank as well as the account holder's name as it is written by the sponsor below. Please note that if you have Optional Practical Training (F-1), Curricular Practical Training (F-1) Academic Training (J-1) or economic hardship (F-1 & J-1) authorization from your previous school, it cancels as soon as you receive your new I-20 from Drew, so you will not be able to continue it. Please fill in the box below and then give this to your sponsor.
